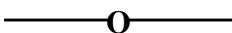

THE ELECTION OF THE DEPUTY SPEAKER OF THE NATIONAL ASSEMBLY OF TANZANIA

Citation	1. This Notice may be cited as The Election of the Deputy Speaker of the National Assembly Notice, 2022.
Public Notice	2. Notice is hereby given to the general public that, following the resignation of the Deputy Speaker of the National Assembly of Tanzania on 31 st day of January, 2022 in accordance with Article 149(1) (c) and (2) of the Constitution, the seat of the Deputy Speaker of the National Assembly is vacant.
Vacancy and election of Deputy Speaker	3. The general public is further notified that, in accordance with Article 85(1), (3) and 86(2) of the Constitution, the Deputy Speaker is elected from amongst Members of Parliament during the first sitting of the National Assembly immediately after the occurrence of a vacancy in the seat of the Deputy Speaker or immediately after that sitting; and for that reason, election of the Deputy Speaker of the National Assembly shall be conducted on 11 th day of February, 2022.
	4. During the election of the Deputy Speaker of the National Assembly, each Political Party represented in the National Assembly has the right to participate in the election by proposing one name of a Member of Parliament from that Party who will stand as candidate in the election of the Deputy Speaker of the National Assembly.
Participation of Political Parties and nomination of candidates	5. By this Notice, a Political Party, represented in the National Assembly which intends to take part in the election of the Deputy Speaker of the National Assembly shall submit to the Clerk of the National Assembly who is the Returning Officer, the name of a Member of Parliament from that Party who will stand as a candidate for the election of the Deputy Speaker not later than four O'clock of 10 th day of February, 2022 at the Office of the National Assembly, situated at Dar es Salaam Road, Makole Street, Dodoma.

The election of the Deputy Speaker of the National Assembly shall be conducted in conformity with the election procedures set out under Order 11 of the Parliamentary Standing Orders, June 2020 Edition, and the Election Rules set out in the First Schedule to the Parliamentary Standing Orders, as extracted in the Schedule to this Notice.
